I, {full legal name} BRAD SCHINDELHEIM, in my position as {job title} DEPUTY SHERIFF with the {name of law enforcement officer/agency} VOLUSIA COUNTY, swear and affirm that the following facts are true and correct.

1. {Name of Respondent} ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On the above date and time, Deputies Potosky and Schindelheim were dispatched and responded to ██████████, Ormond Beach in reference to the report of a suicidal person. Prior to arrival, deputies were advised the reporting person stated the Respondent had threatened to shoot his roommate, ██████████, and then himself. Upon arrival, deputies took tactical positions around the residence, and contacted ██████████ via telephone

2. {Name of Witness} ██████████ provided the following information based on his/her personal knowledge:

█████████ stated the Respondent was intoxicated and talking about harming himself. ██████████ told the Respondent to stop talking that way or he was going to call ██████████ to get him some help. ██████████ stated the Respondent told him to give him one of his guns so he could "shoot himself in the head." ██████████ advised he owns firearms; however, they are in a locked safe which the Respondent has no access to. ██████████ advised he refused to



[REDACTED] exited the front door of the residence and contacted deputies; at which time deputies observed the respondent in the side yard of the residence. Deputies contacted the Respondent, and observed he was unarmed.

Deputies spoke with both the Respondent and [REDACTED], who both stated they reside together at the residence as roommates.

Deputy Potosky contacted the Respondent, while other deputies spoke with [REDACTED]. The Respondent appeared intoxicated, as he was unsteady on his feet, and the odor of alcoholic beverages were detected on his breath as he spoke. The Respondent stated he "know what I said to my sister [REDACTED] over the phone and just wanted to get this over with." The Respondent did not want to elaborate to deputies of what he told his sister or what he said to his roommate [REDACTED]. He stated he did not want to receive medical or mental evaluation/treatment.

Deputies contacted the Respondent's mother, [REDACTED], via telephone, as she was the person who reported the incident to the Sheriff's Office. [REDACTED] stated the following information:

[REDACTED] advised she received call from the respondent's sister, [REDACTED], who was concerned about the safety and well-being the Respondent. [REDACTED] stated [REDACTED] was contacting her because she was concerned because Respondent was making threats about shooting himself and/or his roommate [REDACTED]. [REDACTED] advised upon hearing the threats that were made by Respondent, she contacted the Sheriff's Office. [REDACTED] was not on-scene, and was contacted only by telephone. Due to [REDACTED] not being at the scene, she was unable to complete a sworn written statement.

Deputies then contacted [REDACTED] via telephone, who stated the following information: [REDACTED] advised deputies that she saw a FaceBook post from the Respondent stating that "everything will be ok and this will all be over by Sunday." Upon reading this post, [REDACTED] contacted the Respondent via phone and was speaking with him about what was going on. [REDACTED] advised the Respondent admitted to her that he was intoxicated. She also stated the told her that he was "going to see their father." [REDACTED] advised deputies their father passed away 2 (two) years ago. She advised the Respondent stated his roommate [REDACTED] had a "bullet with his name on it" but would not elaborate on what that meant. Due to [REDACTED] being out-of-county, she was also unable to complete a sworn written statement. Deputy Potosky then contacted [REDACTED] who stated the following information:

Based on the deputies' investigation, Deputy Potosky placed the Respondent into custody under the Baker Act and transported him to Halifax Hospital in Daytona Beach.

It should be noted; throughout the investigation, it was determined the Respondent does not currently own or possess any firearms or ammunition.
