I, *{full legal name}* D/S Eric Dolan, in my position as *{job title}* Deputy Sheriff with the *{name of law enforcement officer/agency}* Volusia Sheriff Office, swear and affirm that the following facts are true and correct.

1. *{Name of Respondent}* ██████████ poses a significant danger of causing personal injury to himself/herself or others by having a firearm or any ammunition in his/her custody or control or by purchasing, possessing or receiving a firearm or any ammunition. The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On 12/30/2021, at approximately 1925 hrs., deputies were dispatched to ██████████ ██████████ Deltona, in reference to a suicidal person. The initial call notes advised ██████████ ██████████ (R1) was calling in advising his boyfriend/partner, ██████████ (V1) had a gun to his head and was threatening to shoot himself. ██████████ was instructed by dispatch to exit the residence and make contact with deputies down the road, which he did. Upon

2. *{Name of Witness}* ██████████ provided the following information based on his/her personal knowledge:

██████████ advised he and ██████████ had been arguing for the past couple weeks and he was ending the 22 year relationship and giving ██████████ until February to vacate the residence. ██████████ stated he returned from a work trip as a long haul truck driver, and when he returned home, ██████████ began arguing and "going crazy". ██████████ stated ██████████ then went into the bedroom to obtain a handgun which ██████████ then pointed at his own head and starting

arrival, deputies established a perimeter around the residence. I was later learned ██████ owned several firearms, which he had access to and was the only person remaining inside the residence.

Sgt McDonald arrived on scene and established communication with ██████ via phone. After several minutes of dialogue, ██████ refused to exit the residence peacefully. Deputy Galarza would later make contact with ██████ who advised the following:

██████ advised he and ██████ have been together for over twenty years but had been arguing for the past several days over their relationship. ██████ advised he had given ██████ an ultimatum and told him he needed to leave the residence in the coming days. ██████ advised upon his arrival home on today's date, he noticed ██████ was agitated and went "crazy" and began arguing. ██████ advised after walking away from ██████ for a few moments her returned to their room and discovered ██████ had the handgun pointed at his head, threatening to shoot himself. ██████ advised ██████ kept repeating "I'm gonna do it". ██████ repeatedly told ██████ he needed to put the gun down, which he refused. ██████ threatened to "blow" his brains out if police showed up.

Due to ██████ refusing to exit the residence peacefully and him not being an immediate threat to others, it was decided deputies would discontinued communication with ██████ ██████ was strongly encouraged not to returned to the residence for the rest of the evening.
