On 07/04/2022, at approximately 1956 hours, Deputy Freeborough responded to Osteen in reference to a suicidal person. Central Dispatched advised a frantic female called in stating a male has a gun, is threatening suicide, and is shooting up his property.

Deputies made contact with
 broke up recently causing her to move out of the residence. After the breakup, very depressed and has recently began drinking alcohol, which he has never done in the past three years since they've been together.
further stated earlier today she received a phone call from $\square$ who stated he has been drinking all day and said "I don't want to be here anymore". Additionally, $\square$ shoot anyone who comes on his property". stated soon after that she went to residence to drop off the rest of his clothes that she had of his. advised she knocked on the door and answered holding what appeared to be a black pistol. Afraid, $\square$ eft, and went back to her vehicle, as got into her vehicle she could heard what she described as five to six gunshots coming from residence was concerned that took his own life and subsequently called law enforcement. stated at no point did point the firearm at her or make any threats. Due to past actions and statements, vould harm himself in the near future if he did not receive help. completed and signed a sworn written statement detailing the incident. It should be noted as deputies arrived on scene, multiple gun shots were heard coming from esidence.

Deputies were able to make contact with via telephone who agreed to meet deputies outside of his residence.

Deputy Freeborough made contact with who stated he recently found out that cheated on him and he has been upset over the situation. $\quad$ stated he only told that he is going to buy an AK for his protection. When questioned about the firearm, stated he has been shooting his black 9 mm Baretta and 40 mm black Glock in his backyard into the ground and had shot approximately 50 rounds. During the interaction with Deputy Freeborough could smell the fragrance of alcoholic beverages admitting from his breath coupled with his slurred speech.

Deputies cleared the residence for any additional victims but were met with negative results. Upon clearing the residence, Deputy Freeborough observed a black in color BB gun on a table near the rear door of the residence but did not locate any firearms. Additionally, Deputies located multiple spent shell casings by the rear door of the residence. Deputy Freeborough also observed recycling cans full of empty Heineken beer bottles with more spent shell casing inside. Deputy Freeborough took photographs of the shell casing and collected the casing later submitting them into evidence.

A criminal history check of $\square$ evealed that he had no prior felony convictions.
Based upon the statements made to Deputy Freeborough determined there was a significant chance may cause harm to himself in the near future. Deputies placed into protective custody under the Baker Act.

Deputy Freeborough later completed a Risk Protection Order (RPO).
