On 01/22/2022, at approximately 1008 hours, Deputy Wallis responded to ██████████, Orange City, in reference to a suicidal person.

Upon arrival, deputies contacted ██████████ (R1), who advised her mother, ██████████ (V1), suffer's from depression and anxiety. ██████████ explained she noticed ██████████ exited her room holding her pistol (Ruger P22; SN# L076063), at which time ██████████ stated, " She did not want to live and wants to end it." ██████████ advised she grew concerned for ██████████'s well-being, so she took the pistol from ██████████'s possession and hid the firearm in her vehicle. ██████████ reported ██████████ then reentered her bedroom and closed the door, to which she called for law enforcement assistance.

Deputies made contact with ██████████ in her bedroom located on the southeast corner of the residence. Upon contacting ██████████ deputies noticed she was watching a homicide documentary. Sergeant Barnes questioned Ch ██████████ in reference to the incident, to which she advised she was feeling depressed but did not want to talk about her depression or past. ██████████ additionally stated she does not want to meet a mental counselor. Sergeant Barnes asked ██████████ if she had her gun, to which she advised ██████████ took her gun from her when she said, " I want to end it."

Based upon the information provided by ██████████ coupled with ██████████'s statements and behavior, Deputy Wallis determined without proper care and treatment, there was a significant likelihood ██████████ would harm herself or suffer from neglect. Deputy Wallis took ██████████ into protective custody under the provisions of a Baker Act, and she was transported to Halifax Hospital. An RPO was completed.
