cell-phone however he became more agitated and began speaking again with [REDACTED]. While speaking with [REDACTED], [REDACTED] stated he would shoot any law enforcement officers if they attempted to interact with him. Deputy Jones contacted VSO teletype and had [REDACTED] input as missing and endangered in FCIC/NCIC. Deputies were eventually able to locate [REDACTED] at the Circle-K gas station, 1380 Howland Blvd, where he was taken into custody without issue. [REDACTED] was subsequently removed from FCIC/NCIC by operator Young. Deputy Jones asked [REDACTED] if [REDACTED] possessed any firearms which she advised he had some guns but she was unsure of what kind. [REDACTED] further stated she believed the firearms were at [REDACTED]'s friends house but was unsure. [REDACTED] (O1). Deputies made contact with [REDACTED] via cellphone however he was uncooperative with deputies.

Deputy Prado completed a Risk Protection Order for [REDACTED]

[REDACTED]'s sister, [REDACTED] (O2), was contacted and advised she would be coming to [REDACTED]'s residence to assist in taking care of their mother but her mother was able to take care of her own basic needs without assistance.

[REDACTED] was transported to Stewart Marchman Facility without issue.
