Deputies were able to make telephone contact with \_\_\_\_\_ to inquire what could be done to deescalate the situation and for a peaceful resolution. \_\_\_\_\_ explained he is stressed over not being able to work, and fighting with the DMV over getting his license fixed. \_\_\_\_\_ came out of the residence multiple times, and quickly retreated back into the home.

Conversation was held and maintained with \_\_\_\_\_ for him to exit the residence. \_\_\_\_\_ exited the residence with a phone in his left hand and a cup in his right hand. \_\_\_\_\_ walked towards deputies with his pants pocket inside out and hands in the air. \_\_\_\_\_ was approached by deputies and explained the situation over again. \_\_\_\_\_ made several statements "that if I'm not able to work I don't have a reason to live". \_\_\_\_\_ was placed in protective custody at 1643 hours without incident.

\_\_\_\_\_ was transported to Stewart Marchman in Daytona for a mental health evaluation. Upon arrival at Stewart Marchman \_\_\_\_\_ made several statements explaining how he was scared when he fired his first round inside of the house. \_\_\_\_\_ went on to say he fired 10 rounds into his television.
