\_\_\_\_\_ stated her husband, \_\_\_\_\_ (V1) had been drinking and feeling depressed, which resulted in him pointing his pistol at his head and threatening to commit suicide. \_\_\_\_\_ subsequently left the residence for her safety and contacted law enforcement about the incident. \_\_\_\_\_ provided no further information in reference to the incident.

Deputies later arrived at the residence and took up perimeter positions at the location. \_\_\_\_\_ was then contacted by telephone and agreed to exit his residence in order make contact with law enforcement. Once contact was made, \_\_\_\_\_ advised his brother passed away approximately one year ago and has been feeling depressed. \_\_\_\_\_ also admitted pointing his pistol at his head during the incident in effort to commit suicide. \_\_\_\_\_ provided no further information in reference to the incident.

Based on the information, Deputy White determined that there was a likelihood that without care or treatment, \_\_\_\_\_ could cause serious bodily harm to himself or others. Deputy White placed \_\_\_\_\_ into protective custody under the provisions of the baker act statute. \_\_\_\_\_ was later transported to Stewart Marchman Facility, located in Daytona Beach for further assistance.

Due to the incident involving a firearm, Deputy White completed a Risk Protection Order. \_\_\_\_\_ however did not wish to turn over \_\_\_\_\_'s firearms to law enforcement due to fearing it would upset him even more. \_\_\_\_\_ further advised she will safely keep \_\_\_\_\_'s firearms. \_\_\_\_\_ also mentioned \_\_\_\_\_ has a pistol and shotgun at the residence.
