The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

[REDACTED] then proceeded to go to his room which he shares with [REDACTED] and the room contains a safe with firearms. [REDACTED] was unaware if the firearms were in the safe as it has a combination [REDACTED] only knows and only he is able to get into the safe. [REDACTED] stated this is not the first time [REDACTED] made suicidal statements while intoxicated. [REDACTED] provided a sworn verbal statement and was provided with an agency card with Deputy Estrella's name, DID, and case number. Deputy Estrella made contact with [REDACTED] during which she stated the following: Earlier today, 03/07/2022, [REDACTED] and [REDACTED] went to Walmart where [REDACTED] observed [REDACTED] drinking an unknown beer and possibly mixed another alcoholic beverage with the beer while in the vehicle. [REDACTED] witnessed [REDACTED] and [REDACTED] arguing and she was upset that [REDACTED] was intoxicated. [REDACTED] witnessed [REDACTED] go to her brother [REDACTED] room and break down the door and state to [REDACTED] "give me a hug I'm going to shoot myself". [REDACTED] proceeded to follow [REDACTED] to his bedroom where she witnessed [REDACTED] go in and close the door. [REDACTED] is aware [REDACTED] has gun safes with firearms in his bedroom. [REDACTED] provided a sworn verbal statement. It was never confirmed [REDACTED] ever gained access to any firearms. Deputy Estrella made contact with [REDACTED] in which he stated the following: [REDACTED] heard [REDACTED] yelling and proceeded to break down the door to his room and state "Give me a hug I'm going to shoot myself." Deputy Estrella made contact with [REDACTED] (O3) who stated [REDACTED] made a gun gesture with his fingers and pointed it to his head. Deputy Estrella observed, from outside the bedroom, of [REDACTED] and [REDACTED] bedroom two large black safes inside the room. Deputy Estrella spoke briefly with [REDACTED] who stated he was upset and did make suicidal statements, but stated he would never act upon those statements. Deputy Estrella believed it was likely without professional care or treatment, [REDACTED] would likely cause serious bodily harm to himself. [REDACTED] was placed in protective custody under the Baker Act. [REDACTED] was transported to Stewart Marchman facility. Director Carla Quann was notified and sent a copy of the report. A copy of this report was forwarded to the Florida Department of Children and Families for review. Case Status: Closed


