On Monday, March 28, 2022 Deputy Lee responded to \_\_\_\_\_ in Debary in reference to a disturbance. Prior to arrival, deputies were advised via central dispatch that the reporting party's husband, \_\_\_\_\_ (V1), made suicidal statements and was sitting in his vehicle out front of the residence. As Deputy Lee arrived on scene, he observed the vehicle as it began to pull away. Deputy Lee conducted a Terry Stop on the vehicle, based on the alleged suicidal statements, and made contact with \_\_\_\_\_ once he exited. As he did, \_\_\_\_\_ was sobbing almost uncontrollably advising that his wife, \_\_\_\_\_ (R1), had cheated on him. Based on his temperament and the alleged statements, Deputy Lee secured him in handcuffs and placed him into the back of his patrol vehicle. He then asked him what transpired and he advised that he and his wife had been separated but one month ago got back together. Yesterday, however, he discovered that she was seeing someone else and came by the house today to confront her about it. He advised that he knocked on the door wanting to talk to her but she never answered, so he got back into his vehicle to leave. He denied making any suicidal statements or gestures.

Deputy Lee then made phone contact with \_\_\_\_\_ who advised that she was working inside the home when she heard him knocking. She approached the door but did not open it immediately and instead yelled through it that she did not want to confront him and for him to leave. After a few moments, he walked to his car and that is when she opened the door. It was at that moment that \_\_\_\_\_ said he would kill himself if she would not be with him and then shaped his hand into the form of a gun and put it to his head. She then called law enforcement to report it. \_\_\_\_\_ provided a signed and sworn statement.

At the conclusion of the investigation, based on \_\_\_\_\_ demeanor and \_\_\_\_\_ statements, Deputy Lee determined that there was a substantial likelihood that without care or treatment, \_\_\_\_\_ would cause harm to himself. He was therefore involuntarily Baker Acted and later transported to Stewart Marchman in Daytona. An inventory search of the vehicle revealed a .40 caliber Glock pistol on the passenger side floorboard, loaded with a round chambered. Also of note was a single live .40 caliber round located on the driver's side floorboard. The weapon and \_\_\_\_\_ concealed weapon's permit were both seized, as Deputy Lee completed and submitted a temporary risk protection order. \_\_\_\_\_ advised that he owns another weapon, a rifle, but that it was inside his apartment in Sanford. A criminal history inquiry of \_\_\_\_\_ was completed which showed he was not a convicted felon.

3. Affiant  is  is not aware of any existing protection order governing the respondent under any applicable statute.




