On 09/29/2023 at approximately 1841 hours, Deputies responded [REDACTED] Debary in reference to a suicidal person. Prior to the units arriving on scene, call notes advised [REDACTED] (R1) who is the sister of the suicidal person explained her sister threatened to shoot herself and is aware of firearms being inside the home.

Upon arrival, Deputies were able to make contact with [REDACTED] (V1) who advised she is currently going through a bad financial situation and can not handle it. [REDACTED] explained she might be homeless soon due to the financial issues and wants to kill herself. [REDACTED] advised she contacted her sister and tell her she did want to kill herself, however, it was a mistake. [REDACTED] said the only reason why she had not shot herself yet was due to her dogs being inside the home and cannot do that to them.

[REDACTED] was asked if she had firearms in the house and she said she had one which was located inside her room in the closet. Deputies asked if [REDACTED] would allow Deputies to retrieve the firearm and gave permission to enter the home and to retrieve it for safekeeping. [REDACTED] also added that it would be a very good idea if deputies took the gun.

Deputies were able to locate a Glock 19 9mm pistol (SN [REDACTED]) inside the bedroom closet along with a box of [REDACTED] 9mm ammo (50ct.). The firearm was collected and later submitted into district 6 evidence locker for safekeeping.
