Contact was made with _____s ex-wife where she forwarded the messages for review. Once the messages were received, they read:

"When I kill myself, I hope you feel the pain, kiddo."

"If you just called the cops on me, you need to call me and clarify, please; otherwise, I'm going to go crazy and a shooting spree and go to prison."

On October 23rd, 2023, at approximately 1723 hours, Deputies Skorewicz and James were dispatched to _____ Debary, in regard to a well-being check requested from Lake Mary Police Department in reference to a possible suicidal person.

Prior to arrival, dispatch advised _____ (V1) was sending his ex-wife suicidal statements. Contact was made with _____'s ex-wife where she forwarded the messages for review. Once the messages were received, they read:

"When I kill myself, I hope you feel the pain, kiddo."

"If you just called the cops on me, you need to call me and clarify, please; otherwise, I'm going to go crazy and a shooting spree and go to prison."

Deputies arrived on scene at _____ Debary at approximately 1750 hours and surrounded the residence. Deputies attempted to make contact with _____ via phone, but he did not pick up. Deputies contacted _____'s mother who also lives at the residence, later identified as _____ (O1), who advised she was not there, but her son _____ was.

_____ additionally mentioned to Deputies that _____ has multiple firearms in the residence. Due to _____'s previous statements and his access to firearms, Deputies made announcements via the PA system with a patrol vehicle and requested _____ to exit his residence.

Soon after, _____ complied and surrendered to Deputies where he was placed in protective custody under the Baker Act. When Deputies questioned _____ about why he made threatening statements, he advised his ex-wife used him for his money, which caused him to become distressed.

Due to the nature of _____'s threats involving firearms, Deputies asked _____ if he would consensually surrender his firearms due to his mental state. _____ refused and was not willing to surrender his firearms. _____ was transported to SMA without further incident. Due to _____ making threats involving firearms, an RPO was completed.


