On 04/02/2023 at approximately 2240 hours, Deputy Jones responded to \_\_\_\_\_ in reference to a suicidal person. Prior to arrival, Deputy Jones made contact with the reporting party, \_\_\_\_\_ (R1), via cell-phone who advised the following:

\_\_\_\_\_ was texting with her husband, \_\_\_\_\_ (V1), during which \_\_\_\_\_ began eluding to killing himself. \_\_\_\_\_ provided photographs of messages between she and \_\_\_\_\_ in which \_\_\_\_\_ stated the following phrases: "Yours isn't here so I'll use mine", "Don't worry, you'll get the house you can't afford and my life insurance", "Front door is unlocked and light is on", "\*\*\*\*JUST FOR YOU\*\*\*\*", "I'll see ya, I'm treated like shit", "Bye", "Can't talk to me for shit. Enjoy the purple toy. I'm gonna put your pink one to my head here in a minute". \_\_\_\_\_ texted \_\_\_\_\_ back stating she was going to call someone for him to which he texted back the following: "Lawls.... you won't talk to me at all and this is the convo", "I'll be gone before they get here", "I'll see ya", "I know you'll enjoy that ", "Want a video?", "Don't know how I'll send it but you'll get it", "I unlocked the front door. I'll be in my office.", "Tanner is the only one that wants me around", "You hate him and me". \_\_\_\_\_ stated she believed there were two 9MM handguns in the residence as well as an unknown amount of firearms in a safe.

Deputy Jones was able to make contact with \_\_\_\_\_ via cell-phone at which time \_\_\_\_\_ complied with law enforcement and was taken into protective custody. \_\_\_\_\_ denied sending any concerning messages initially and after being confronted with the message regarding the "pink one", \_\_\_\_\_ stated he was talking about a sex toy.

Based upon the evidence gained, Deputy Jones determined that without proper care or treatment, \_\_\_\_\_ would likely cause harm to himself as evidenced by recent behavior.

\_\_\_\_\_ was transported to Stewart Marchman and a Risk Protection Order was completed.

Digital photographs of the messages were uploaded to Digital Crime Scene.




