She walked into the backyard and saw _____ pointing a loaded handgun at his own neck. _____ asked him what he was doing and _____ advised "practicing". _____ also witnessed _____ put a box with money outside and he said it was for his daughter, indicating he would not be there anymore. Sgt Carelli made contact with _____ who advised the following - _____ denied the allegation but told deputies where they could locate his firearm. _____ also advised the only reason he was at home and not at work was because his boss had angered him. _____ advised he wanted to punch his boss in the face. _____ wife, _____ (O1), responded to the scene and advised the following - _____ had received concerning text messages from _____ which made her think he might be suicidal. _____ had sent _____ over to the house, as _____ was further away, to keep an eye on him. Deputy Pugliese observed two spent .40 caliber casings in the backyard of the residence, consistent with a .40 caliber gun having just been fired as they laid on top of the ground and appeared to not be weather worn. Deputy Pugliese submitted digital photographs of the spent casings to Axon Digital Evidence. Deputy Pugliese determined probable cause existed to place _____ into protective custody under the Baker Act as he posed a threat to both himself and others. _____ was transported to Halifax Daytona without further incident. Deputies seized the firearm, a Glock 27 .40 caliber handgun (Serial #: HPC944) and submitted it to the District 4 Evidence lockers pending RPO approval.
