COURSE:

This course is part of the Criminal Justice Standards and Training Commission Advanced Training Program. Courses in the Advanced Training Program are designed to enhance an officer's knowledge, skills and abilities for the job he/she performs. The course will provide insight into investigating the complexity of these types of crimes. The student will understand how to conduct the initial crime scene investigation when a death is involved.

All students must pass a final written exam with a minimum score of 80%. Attendance is mandatory for all sessions of this course.
